

DESCENDANTS OF JOHN ALLISON(**Rev. April 19, 2012**) [MY NOTE: It is of interest, that in 1770/71, **Dr. William Allison** is cited in a court record of Caroline Co., VA. This raises a question -- when William Allison became an heir of his grandfather, John Allison of Frederick Co., MD in 1768 -- did William leave Wilkes Co., NC and travel back to Maryland to obtain his inheritance and thus be able to afford apprenticeship for medical practice? Virginia land records also show land grants to William Allison 1769-1771. Notable too, is the gap in NC tax records for William Allison between 1768 and 1771. Was it Dr. William Allison who passed on the legacy of medical practice through his daughter, Nancy, who later married Braxton D. Cox?]

John Allison, Jr., b. ca. 1729; marr. Unk.; **ISSUE per 1768/69 Will of John Allison** above:

1. **William**, [1762 Nov - **William Allison**, aged 13 yrs, 12th day of March last, an **orphan**, is by the Court here bound to Godfrey? Brown till he arrives at the age of 21 yrs. Said Brown is to learn him the trade of a house joyner and to learn him to read, write and cypher as far as the rule of three and when free to give him a decent suit of apparel.] (1750-1762 Frederick Co., Md. Court Min., p. 316; MSA Microfilm Roll CR 12,257)
2. Henry [Nov. 1762 - **Henry Allison**, aged 12 yrs last August, an **orphan**, is by the Court bound to James Harbin till he arrives to the age of 21 years; said Harbin is to learn said orphan to read, write and cast accounts and when free to give him a decent suit of apparel. Source: 1750-1762 Frederick Co., Md. Court Minutes, p. 314. (MSA Microfilm Roll CR 12,257)

William Allison b. abt. 1749 in MD; d. 1809 Wilkes Co., NC; abt. 1763 he married "Lucy" Lucinda Thompson who d. 23 Jan 1824 Wilkes Co., NC . [Jun 1809 Will Wm. Allison heirs: wife, Lucy, sons John, William, Daniel, Hugh, James, Ephraim, Samuel & Benjamin; children of daughters Susannah Dula, **Nancy Cox**, Polly Foster; daughter Avarilla Allison; granddaughter Betsy Morrice(sic). Wilkes Co., NC Will Book 3, pg. 170.] [The will was contested in 1818 & petition for partition made in 1822] **ISSUE:**
