**1657** Nov 20 patent for "BromweH" (bo spelled) on 20 Nov. 1658. (500 acres, running N.N.E. up the N. side of Hunting Creek, a tributary of Patuxent River, surveyed 22 July 1656. and re-surveyed for **Richard, son and heir**, in 1674.) In his will he appoints his "well beloved neighbors, and tinue and trusty frienda," Wm. Parrott and Wm. Turner, overseers, but the latter appears to have robbed the chil. of their estate.
