1741 May 11, **John Henry** Estate - payments to creditors & heirs.

1742 Aug 17 - **John Henry** Estate - payments to creditors & heirs.

1745 May 29, Pr.Geo. Co., MD Land Records Bk BB#1 - James Lucas sold Isabella Henry household goods, 3 sheep, etc.

1704 Dec 20 - Ninian Beall, Sr., Pr.Geo. Co., MD to Nathaniel Taylor, Minister of Gospel - "Meaddows" on br. of Patuxent River.....names John Henry, et al.....

1725 Feb 8 - Memo to Justices of Marlborough Town.....Depo of **John Henry, age 76** etc.

1728 May 25 - **John Henry**, planter, to Alice Lindoce (d/o Alexander Lindoce, blacksmith, dec'd), 50ac parcel named "Mannoccosy" part of a 300 ac parcel left to John Henry by Wm. Castor.....

1731 Mar 25 - Ann Beckwith of Upper Marborough to Basil Beckwith ½ part of lot in Marlborough of 1 ac. belonging to **John Henry** now in possessin of Ann Beckwith.....Pr. Geo. Co., MD

1731 June 4 - Petition of Wm. Young..... mentions **John Henry, age 80 yrs**.....
