Clayborne 9 years past. Warrant to lay out 200 acs of land for Hugh Hopewell & Thos. White at Hogpen Tavern Neck or near Sanawakett on the s/s Patuxent River; p. 270 - Oct. 6, 1650, laid out for Hugh Hopewell & Thos. White, planters, a parcel of land lying on so. side of Patuxent River called Hogpen Neck.; p. 332 Laid out more for Hugh Hopewell and Tho. White another parcell.....lying on so. sd. of Patuxent River beg. at Warrs Spring, running east by said river to land of Francis Vanenden....unto land of Thomas Warr.
