George Co., VA Will of Elizabeth Ivey heirs: sons: George, Henry, John, Gilbert; daughter Susan Hays; son Adam & his daughter Elizabeth.]; ISSUE: 1. **George** 2. Henry 3. John 4. Gilbert 5. Adam 6. Susan marr. Mr. Hays

### Generation 2

**GEORGE IVEY/IVY**, d. after 1737 [Nov 14, 1737 Will of George Ivey gave gift deed of 145 acs near Pigeon Swamp in Sussex Co. to son, Henry who with wife, Rebecca 2 months later sold the the 145 acs.]; marr. Ruth; ISSUE:

1. Henry

**Note:** Aug 16, 1738 George Wyche sold 400 acs in IOW to "Henry Ivy, son of George Ivy" of Surry Co. - IOW DBk 5/p247].

**HENRY IVEY/IVY, Sr.** d. 1774; marr. 1) Rebecca Sledge; 2) Phyllis Sammons [Will Feb 15, 1774, Southampton Co.; heirs: wife, Phyllis; sons John, Robert, Charles and Henry, son Joseph dec'd; daughter Sarah (& Sarah's own daughter, Phoebe), daughter Mary Adams] ISSUE:

1. John 2. Robert 3. Charles 4. **Henry** 5. Joseph 6. Sarah 7. Mary, m. Mr. Adams 8. Gathwaite

### Generation 4

**HENRY IVEY/IVY, Jr.** [Jan 26, 1791 (prob. Apr 14, 1791) Will of Henry Ivey/Ivy heirs: wife, Winny; sons: Adam, Peterson, Wyke; daughters Charlotte Knight, Elizabeth Newsom, **Sally Ivey & Rhoda Ivey**] married: 1) Ms. Peterson?; 2) Ms. Wyche?; 3) Winifred (was too young to be mothers of Henry's older children - perhaps Rhoda being her only child?. She named none of them in her will. See Reference #1 below.
