

## DESCENDANTS OF JOHN MOSS

**John Moss**, b. abt. 1634 prob. England; d. 1697/98 Essex Co., VA [1697 Dec. 22 - Will of John Moss refers to **William Cox as son-in-law**. Also refers to John Boughan as brother-in-law. Will gives guardianship of Mary Moss, daughter of John to William Cox. The Moss Will also refers to Maj. James Boughan as brother & made guardian of daughter, Elizabeth Moss.] marr. Mary Boughan : ISSUE:

1. Anne (she was extrx. of John Moss estate in July 1698; she was heir to 100acs)
2. Elizabeth
3. Unk (marr. William Cox as indicated above. See [Cox Family](#))
