Wife/Mary - All land during her life..... son, Darby (feather bed); Dau., Rachael Andrews (feather bed); son, Ambrose (cows & calves); son-in-law, Jacob Adams (12 measures feed Son In Law); John Rigggen (12 measures of feed), 1/3 of remainder estate; Rachael Andrews, 1/3 of remainder estate; Samuel Rigggen, 1/3 of remainder estate; remained ofpersonal estate...equally divided between these three. /s/Teague mark.
